Who gets the data?

- Flock registers more than 16,000 vehicles per day in WDM
- Each plate is sent to the FBI in real-time to perform a "hotlist" check.
- >300 organizations have access to West Des Moines' data.
- Jemison, AL is one of them.







"Intelligence data" means information on identifiable individuals compiled in an effort to anticipate, prevent, or monitor possible criminal activity

"Surveillance data" means information on individuals, pertaining to participation in organizations, groups, meetings or assemblies, where there are no reasonable grounds to suspect involvement or participation in criminal activity by any person

5. "[Police] shall not disseminate intelligence data, which has been received from the department or division or from any other source, outside the agency"

Re: Personnel Complaint, Flock Cameras

Dear Mr. van Pelt,

The Clive Police Department has received and investigated your concerns listed in your April 10, 2024, email to Lt. Herzog. Following such review, the Police Department determined there is no violation of Iowa law by the actions you cited therein. This matter is determined to be resolved.

As the City understands this request, some of the requested information and documents qualify as attorney-client privileged communications and/or "work product of an attorney, which are related to litigation or claim made by or against a public body," which are prohibited from disclosure under Iowa Code section 22.7(4). The remaining documents in the City's possession that are not within the above-described objection have previously been produced to you in response to your April 10, 2024 complaint. Those documents are produced herewith and marked as Exhibit E.

100 license plate reader cameras are live in SF. Mayor to criminals: 'You are going to be caught'



THE ALERT

ACSO Investigations put out an alert for Reed and the vehicle registered to him, and sure enough, a license plate reader led the Kansas Highway Patrol directly to Reed. They booked him into the Leavenworth Detention Center, and soon after, he was brought back to Alameda County on a fugitive, no-bail warrant and put in Santa Rita Jail. Officially charged with two counts of murder, Reed faces up to 50 years in prison.

When a <u>tragic hit-and-run</u> shook Las Vegas in 2019, Sighthound's ALPR+ system was crucial in turning the tide. With its advanced recognition algorithms, the system swiftly scanned through countless plates, identifying the perpetrator's vehicle from sparse details.
